In accordance with BSNL, New Delhi letter cited under reference, the Limited Internal Competitive Examination for promotion from JTO(Electricals) to SDE(Electricals) under 33% quota for vacanciy years 2011-12&2012-13 will be conducted on 24.11.2013(Sunday) as per the Scheme and syllabus circulated vide BSNL Corporate office letter No.1-23/2/EW-2004 dated 20.08.2010. The eligibility service conditions and other details for appearing in the said examination will be as per the SDE(Electrical) Recruitment Rules of 2002 circulated vide BSNL Hqrs. Letter No.20-1/2001-Pers-II dated 28.02.2002 and as amended from time to time.

As per BSNL letter No. .1-23/2/EW-2004 dated 20.08.2010, the minimum pass marks prescribed for each paper is 50% in respect of OC and 45% for SC/ST candidates. There would be negative marking for each wrong answer. 25% of the mark of that question would be deducted.

Examination paper will be OMR(Optical Mark Reader) answer sheet based and as such each question will have multiple choices for answer.

Officials who are eligible in accordance with the eligibility conditions as referred above and who desire to appear in the examination should submit the applications in the prescribed pro-forma (Annexure) through proper channel to DGM(HR) O/o CGM., T.N.Circle, Chennai-2 positively on or before 09.09.2013(Monday). Application received from the eligible candidates after the last date i.e 09.09.2013 should not be entertained.

Applications forwarded without the recommendation of the Controlling Unit/SSA will not be entertained. The candidature of the candidates whose applications are found to be incomplete or inaccurate or not in the prescribed format are liable for rejection.
