Subject: Repatriation of Group 'A' officers of various services working on deemed deputation in BSNL/MTNL back to their parent Department of Telecommunications (DoT)- Regarding.

Reference: This office letter No. A-11013/31/2008-Abs.Cell dated 22.09.2011.

Through DoT Office Memorandum No.A-11013/31/2008-Abs.Cell dated 22.09.2011, all serving Group 'A' officers of Indian Telecom Service (ITS), Telegraph Traffic Service (TTS), Telecom Factory Service (TFS), P & T Building Works Service (Civil, Electrical & Architectural), Indian P&T Accounts and Finance Service (IP&T A&FS) and General Central Service (GCS) working on deemed deputation in BSNL/MTNL were asked to exercise their option for absorption in BSNL/MTNL or to continue in the Government service. It was also stipulated that officers not exercising any option will be deemed to have opted for Government service and that no conditional option shall be accepted and any such offer shall be treated as if the officer has not exercised option for absorption in BSNL/MTNL.

- 2. By the same above-said O.M. dated 22.09.2011, the last date for exercising option by officers was prescribed as 08.11.2011. Several officers have given their options for absorption in BSNL/MTNL or for Government Service in response to above OM. Action to consider issue of Allocation Order (Presidential Order) in respect of those officers who have exercised option for absorption in BSNL/MTNL has been initiated.
- 3. There are many officers who have approached various Courts (CAT and High Courts). In some cases some of the Associations have also approached the Courts. Thus, all the Group 'A' officers on deemed deputation in BSNL/MTNL fall in the following categories with respect to the absorption process:—

Category I Officers who have opted for MTNL/BSNL.

Category II Officers who have opted for Government Service.

Category III Officers who have approached different Courts where hearing is in progress but no stay order has been granted by these Courts.

Category IV Officers who approached the Courts and where the Courts, as per records obtainable in DoT, have granted interim stay or given interim directions. Besides, any officer who has already obtained a stay order as on the date of issue of this order from a High Court or CAT, such officer should immediately intimate the fact to the Cadre Controlling Authority with a copy to the Absorption Cell (attention Mr. D. C. Madan, Under Secretary (Abs. Cell), Fax: 23372100 / e-mail: dcmadan@gmail.com).

Category V Officers who do not belong to Category IV and have not given any option or have exercised conditional option.

These officers are deemed to have opted for Government Service, by virtue of para 10 of O.M. dated 22.09.2011.

- 4. The list of officers falling under category IV above where interim stay orders have been given by the Courts is annexed.
- 5. With the expiry of last date prescribed for exercising option, the period of deemed deputation will end. As such, the officers who have either not exercised their option or have opted for Government Service or have exercised conditional option, therefore, stand reverted to Government. Officers belonging to Category I would not revert back to Government since action to consider issue of Allocation Orders (Presidential Orders) respecting them, has been initiated.

- 6. All Group 'A' officers on deemed deputation to BSNL/MTNL excluding those in Category I and IV thus stand reverted to Government and should report to DoT immediately after having been relieved formally by BSNL/ MTNL, as the case may be. They should be directed to do so by reporting to Sr. DDG (TEC), Telecommunication Engineering Centre (TEC) at 3rd Floor, Teletorium, Khurshid Lal Bhawan, Janpath, New Delhi –110001 with a copy to the Cadre Controlling Authority and Director (HRD) of BSNL/MTNL. Besides, they should give their address, telephone/ mobile number and e-mail id for contact/ correspondence and may not leave Hqs., i.e. New Delhi without appropriate approval.
- 7. Above-said reversion to Government and reporting to DoT in the manner afore-mentioned will be on transfer. These officers will seek their transfer entitlements including joining time from Sr. DDG (TEC). BSNL/MTNL will issue Last Pay Certificates (LPCs) in respect of the officers relieved at the earliest for timely action to disburse pay and allowances to the officers by Sr. DDG (TEC) who shall also deal with the personnel matters/claims relating to the repatriated officers.
- 8. Separate orders will be issued for assigning duties and responsibilities to the repatriated officers.
- 9. Since these orders apply to officers on deemed deputation to BSNL/MTNL, they do not apply to other officers working in the Department of Telecommunications, its attached offices as well as Department of Posts.
