Sub: Calling for Volunteers for Looking after arrangement in the Grade of DGM - Reg.

- 1. Tentative Vacancies of DGM posts to be looked after by DEs have been identified, as per ANNEXURE I, (Copy enclosed) due to retirement on superannuation from June 2014 to December 2014 and are likely to be filled up.
- 2. All the eligible SC / ST Officers, who have completed 4 years of service as DE Adhoc, may exercise their options for Looking after as DGMs in the abovementioned SSAs / UNITS.
- 3. The Circle Office will consider posting of DEs to the station considering their options and based on their seniority. However, for specific administrative requirements, in specific cases, the discretion of posting is vested with the Circle Administration.
- 4. In the first instance, the DEs will be transferred to the new stations and subsequently will be given looking after arrangement in the new station.
- 5. DEs who are transferred to the new station, will have to stay in the new stations for at least two years before seeking any transfer.
- 6. The options of DEs, who will be retiring within six months from the date of consideration for posting as DGM (Looking After) will not be considered in case the options involve transfer to that station. Such cases can be considered only on the officer's own request.

- 7. On posting of regular JAG or Senior DE at a station in future will lead to reversion of the junior most in that station and in such a case, the reverted officer will be retained as DE at that station.
- 8. Consolidated options may be sent to this office by the SSA/Unit Administration through Intranet in the following MS Excel Format as "DGM option XXX..xls" to the folder "Circle Office//staff//AD S-I," which should be made available on or before 25/06/2014, in the standard format given below. Options received direct will not be considered at any cost.
