This looking after arrangement is made on local ad-hoc basis and this will not confer any right on them to continue in the post/station/grade.

The officers may be reverted automatically on completion of 89th day of looking after or regular incumbent joins whichever is earlier without awaiting orders from this office.

It may be noted that separate reversion orders for the officers will not be issued from this office henceforth. However the date of completion of 89th day may be intimated to this office one month in advance.

On termination of these looking after arrangements, the officers will be reverted to their regular posts from where they are promoted unless otherwise ordered in the Leanwhile. In case any vigilance/disciplinary case is pending / contemplated against any of the officer or any punishment like stoppage of increment is current, the looking after arrangement should not be given effect to in respect of the officer and the fact should be intimated to this office immediately. The above arrangement is purely temporary and is likely to be withdrawn at any time without assigning any reason.

Any request for change of posting will not be strictly entertained. The officers may be relieved as ordered above immediately so as to assume the new assignment. In case any of the officer is not willing and does not join the new post as stated above, the order will automatically stand cancelled in respect of the officer and the officer will be debarred for a period of one year from the date of issue of the order. In case the relief of the officer is deferred due to administrative reasons, the same may be intimated to this office immediately.

The relief of the officers should not be deferred on the ground that the officers have given a representation. In case any of the officer is not willing to take up the assignment due to any reason, the same may be obtained in writing from the officer and forwarded to this office immediately.

The above arrangement is without any extra remuneration/fixation benefits. The officers shall not exercise the statutory powers of JAG of ITS Group'A'.
