Subject: Launch of new tariff for CLI based account less Internet dial up (NETONE) services over PSTN & ISDN through CDR platform.

Approval of the Competent Authority is hereby conveyed <u>for introduction of new tariff for CLI based account</u>
<u>less Internet dial up (NETONE) services through CDR platform.</u> The tariff for Netone services shall be available for both PSTN & ISDN subscribers by merging the earlier two separate components (i.e. Internet Usage and Internet access call charges) into a single component i.e. on per minute call charges basis. This tariff will be applicable for 172222 & 172223 only (not for other dial up services). The details are as follows:-

For PSTN Customers

Charges per minute (including Internet Usage and Internet access call charges)
Rs. 0.25 per minute
Rs. 0.20 per minute

For ISDN Customers
