Kindly refer to the letters cited above. In addition to the instructions provided for providing Mobile Connections to the Local Body elections, further details are provided in this letter as some of SSA have requested for clarifications.

In the letter vide ref. 1, the SSAs were requested to collect the requirements under three categories viz.,

- 1. No. of SIMs with OG only within CUG (Now merged with Category 1)
- 2. No. of SIMs with OG beyond CUG & within Threshold limit (Referred as Category 1)
- 3. No. of SIMs with OG beyond CUG (Referred as Category 2)

The category in Sl.No. 1 has been removed and the connections for that category has to be given as per Sl.No.2 for which the amount to be collected is Rs.220/- (Rs.99 Rental + Rs.121 Threshold) which has to be provided to Booth level PRO & others as specified by DEO and no bills will be generated for these numbers.

For the Sl.No. 3 the advance rental will be collected and usage bill will be generated as per the actual usage, for which the amount needs to be collected after invoice generation by the respective SSA from the DEO Office. These connections have to be provided to DEO, Observers & other officers as specified by DEO only.

Also the specified commercials do not include Service Tax. Taxes are to be included @ 10.3% extra for the category 1 (i.e., for Rs.220/- One time charge per SIM card) and for the other category the service tax will be included in the bill along with actual usage.

The Activation Charges may be waived for all the connections and there is no Security Deposit for category 1 (i.e., for Rs.220/- One time charge per SIM card) and for the other category Security Deposit of Rs.100/- may be collected in addition to the Adv.
