Subject: Voice only facility on FTTH – reg.

Kindly refer Circular R&C-CFA No. 03/13-14 dated 03-04-2013, wherein "the approval of Competent Authority was conveyed to allow voice only facility on FTTH & FTTH subscriber to choose any existing landline voice plan subject to the minimum FMC commitment of Rs. 499/- or above".

2. Above has been reviewed & in order to promote the FTTH services, the Competent Authority has decided to continue/extend voice only facility on FTTH. The condition of minimum FMC commitment of Rs. 499/- has been reviewed & now any landline plan of Rs. 180/- and above may be offered on promotional basis for 90 days, subject to following conditions:-
 - a. Such customers shall not be more than 20% of the total FTTH capacity in the city.
 - b. Such FTTH connections shall be provided at the places where ever telecom services are not feasible on copper network.
3. All other terms and conditions, as mentioned in earlier circulars, shall remain unchanged.
4. These instructions shall be effective with immediate effect in all the circles.
5. This circular is issued based on the approval of Competent Authority in Broadband Cell File No. 64-218/2012/FTTH Tariff.
