- 2. The customers who did not get their validity extended before GP-I or they have balance less than Plan voucher amount and are due for entering into GP-II after expiry of GP-I, should be reminded again to extend their plan validity on 10th and 11th day of GP-I through SMS or IVRS or customer care etc. For GP-I customers not having sufficient balance (i.e., balance less than Plan voucher amount) in their prepaid account and in the absence of a response or inaction by the customer, the plan validity of the customer may be extended on the last day of GP-I state after deduction of the plan voucher amount of the Plan of Rs. 8 from the account balance and intimated accordingly.
- 3. All the other terms and conditions will remain same.
- 4. The above tariff will be applicable with effect from 25.03.2015. The implementation of the tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order and orders/guidelines/clarifications issued by TRAI from time to time.
