Sub: Revised procedure for Prepaid CUG - reg

With reference to the above subject it is intimated that as per the approval conveyed for the implementation of the New Procedure for CUG Number Addition/Deletion by S&M, T.N Circle and change of principle number may be implemented in IN with immediate effect.

The revised procedure is as follows,

1.Re-Admission of Number

At present the re-admission of the number into the group will be entertained only if the request received from the Principal Number, which is proposed to relax that the SMS can be initiated by the Customer himself instead of from the Principal Number using the following syntax.

READMIT <CUG_ID> to 53733

upon receipt of this SMS, IN shall validate the number and the CUG Group ID. If it matches and having sufficient balance, IN Shall re-admit the number in to the CUG Group after deducting the prescribed amount. And also SMS may be initiated to the Customer regarding re-admission. In case if it fails in the validation then also suitable SMS may be sent to the customer. In any case if the number has been deleted upon receipt of SMS from the Principal Number for doing so, it need not be re-admitted.

2.Deletion of Number from CUG Group

For deletion of the number from the CUG Group, the SMS has to be initiated by the Principal GSM Number only, since the Person designated as Principal GSM Number might have planned for SIZE of the Group towards his commitment for the monthly rental component .The syntax for this is

DEL <CUG ID> <GSM NUMBER TO BE DELETED> to 53733
