BSNL is providing Mobile, Blackberry, Data Card, Landline and Broadband service to Income Tax Deptt. under Project "TARANG". Clarifications on different issues regarding provisioning of connections were requested by various BSNL circles from time to time. Case was taken up with BSNL CO and following has been decided:

1. Shifting charges of landline connections (local/outside) is totally waived off.

2. Normal tariff may be applied for Blackberry services beyond the agreed quantity. In similar way for other services to ITD namely Mobile, Landline, Broadband and 3G data card etc. normal tariff may be applied like general customer for services beyond the agreed quantity.

3. 3G Mobile SIMs & Micro SIMs in lieu of already allotted 2G Mobile SIMs may be

issued on individual payment basis as per the normal customer

4. Any of the following existing stand alone BBG plans on the ITD's office landlines may be offered on actual chargeable basis.

a) BBG 275 (Limited usage plan with 1 GB Download, upto 2 Mbps Speed)

b) BBG ULD 795 (unlimited usage plan with the speed upto 2 Mbps till 8 GB, 512

Kbps beyond)

- 5. For counting of no. of landline connections working on PRI, it is decided to count the landlines on actual basis in step-up of 50 Nos. (Fifty), fractional no. of landlines are to be counted into next higher side of 50 Nos. (i.e. 43 Nos., are to be taken as 50, 67 Nos. are to be taken as 100 and so on) subject to the following conditions:
 - a) Technical feasibility of the proposed solution may be ascertained beforehand.
 - b) Any charges (other than provisioned in the agreement) if any, may be taken from the customer.
